Allowances like T.A., D.A., and H.R.A. etc. are not admissible except consolidated monthly remuneration.

❖ **How to apply:**

- 1) Interested candidates may apply in prescribed application form attached with advertisement (Page no 4&5) with a recent passport size photographs and a set of attested photocopies of testimonials/certificates/ID proof etc
- 2) Application is to be submit on A4 size paper only.
- 3) Applications can be either sent through registered/speed post or can be submitted in person in the office of the “ **Civil Surgeon, District Hospital, Main Road Chhota Bazar , Chandrapur 442402**” on all working days between the advertised date and closing date where the candidate(s) wish to apply.
- 4) Last date for submit the application is **10 July 2025 till 5.00 pm**, applications received after this date will not be considered.
- 5) All further correspondence will be done only by email. (Call letters etc.). So, all candidates applying are required to write their personal email ID and contact number on application correctly and neatly in the application form.
- 6) Candidate should apply separately for each post.
- 7) After scrutinizing, the applications received in due date, short-listed candidates will be called for written examination / interview.
- 8) Written Exam well be conduct on General Knowledge, Subject Knowledge, Post knowledge, Aptitude & HIV/AIDS etc. for 70 Marks.
- 9) Interview will be conduct for 30 Marks.
- 10) Candidate, who gets 35% marks in Written Exam, will be selected for Interview.
