2. Non-refundable application fee of ₹100/- (except SC/ST/Divyang/Women Candidates) to be paid online through <https://www.onlinesbi.sbi/sbicollect/> (Steps to follow: Educational Institutions → Category → Agharkar Research Institute-MACS → Payment Category → Application Fee → Enter Necessary fields / details etc.). Candidates should attach the receipt of online payment of fees and indicate the online receipt number in the application form.
